#### Financials

A. Financial Reports – The financial report for The Learning Academy of Santa Rosa was presented by Ms. James. Ms. James stated that the balance sheet looks good with cash at \$201,360. Revenue is right on target at 94% and expenses are in line at

- 86.94%. The ending fund balance is \$229,829 and budget was \$149,646. Mr. King motioned to approve the financials and Dr. Perry seconded. Motion passed.
- B. 21-22 Amended Budget Ms. James stated that FTE increased the income. Budget was for 100 students and 4<sup>th</sup> calculation was at 115. Referrals and capital helped increase income. Ms. Glover did a great job managing expenses. Mr. King made a motion to approve the amended budget, seconded by Dr. Perry. Motion passed.
- C. Audit Update Ms. James has been working closely with the auditors and together they went to the school for testing.
