#### V. Reports

- A. Learning Academy Director's Report & Title I Update Mr. Sansom provided the Director's report for The Learning Academy and stated that he and Mr. Thorpe have worked very diligently to complete the contract renewal. Mr. Sansom stated that all the faculty and staff are very excited about the upcoming school year. It was mentioned by multiple attendees that Ms. Moorer is doing a fantastic job, communicating well, and has an overall positive attitude about the upcoming school year.

# VI. Discussion & Action Items

A. 2024-2025 Learning Academy Contract Renewal

Dr. Perry made a motion to approve the contract renewal, Mr. Lynn seconded. Motion passed.

### **Human Resources**

A. Learning Academy Personnel Recommendations – The personnel report for The Learning Academy was presented by Ms. Daters. The Learning Academy has 9

current employees with 1 open position for a part time bus driver. Dr. Perry made a motion to approve the personnel report, Mr. Lynn seconded. Motion passed.

### **Financials**

- A. Learning Academy Financial Reports Ms. Griffin presented The Learning Academy Financial Report. She stated that the balance looks good with cash at \$514,599.16 at the end of the 2023-2024 school year. Revenue was above target at 114.2% and expenses were slightly above our original projected at 105.1%, but overall the 2023-2024 school year income and expenditures were in line with the budget. Dr. Perry made a motion to approve the Financial Report, Mr. Lynn seconded. Motion passed.
- B. Learning Academy 24-25 Budget Ms. Griffin stated that the new projected budget goes from July 1, 2024-June 30, 2025. The revenue budget is projected at \$1,074,356.49 and expenses are projected at \$1,116,570.47. The new budget projects our ending fund balance to be around \$472,385.18. Dr. Perry made a motion to approve the 24-25 Budget, Mr. Lynn seconded. Motion passed.
- C. Audit Update-Ms. Griffin also presented an audit update stating that financial documents have been submitted to the auditor, and she will continue to work closely and provide any requested items.

#### General

- A. Board Membership Dr. Schnell asked the board to keep in mind any potential new board members.
- B. Next Board Meeting The next board meeting will be tentatively scheduled for September.
